Introduction

The Alaska Workers' Compensation Appeals Commission is charged with the responsibility of providing fair, prompt and thoughtful adjudication of appeals from the Workers' Compensation Board. The appeals commission provides a consistent approach to reviewing workers' compensation cases by a balanced panel experienced in workers' compensation law. The commission is committed to ensuring that "hearings in workers' compensation cases shall be impartial and fair to all parties and that all parties shall be afforded due process and an opportunity to be heard and for their arguments and evidence to be fairly considered." AS 23.30.001.

The commission chair has certain duties prescribed by law. One of the chair's duties is to "not later than March 15th of each year, make available to the public and file with the lieutenant governor a report regarding the commission for the prior calendar year, including data regarding time periods between initial receipt and final decisions on appeals." AS 23.30.009(c). This is the third annual report of the chair.

• Commission Members

The commission consists of a chair and four representative members. Each representative member must each have at least 18 months of experience as a member of the Alaska Workers' Compensation Board. Two members represent employees and two members represent employers. The chair must be an attorney who has been engaged in the active practice of law at least five years in the State of Alaska, with experience in workers' compensation law in this state. The Chief Administrative Law Judge announces and reviews the applications for each vacancy on the commission and forwards a list of qualified nominees to the Governor for appointment. The Alaska State Legislature must confirm appointees. A seat on the commission falls vacant every year as terms are staggered.

At the time of writing, the present representative members of the Commission are, in order of expiration of term:

- Philip E. Ulmer, Eagle River, is a registered professional engineer, currently employed as manager of safety and workers' compensation for GCI. He is a previous national president, American Society of Safety Engineers and of the National Institute for Engineering Ethics; and a 1994 Engineer of the Year finalist with the Alaska Society of Professional Engineers. He served as a member for industry on the Alaska Workers' Compensation Board. He was appointed to a four-year term in November 2005. His term expires March 1, 2009. Employer representative.
- Kristin Knudsen, Anchorage, from 1989 until her appointment, was employed by the Alaska Department of Law as an assistant attorney general specializing in workers' compensation law. She has been a hearing officer for the Alaska Workers' Compensation Board, an appellate brief writer for claimant's attorney Chancy Croft and a contract hearing officer for the Oregon Workers' Compensation Appeals Board. She received her J.D. degree from Santa Clara University in California and a bachelor's degree in history from the University of California Los Angeles. She was appointed in November 2005 to serve a five-year term as the appeals commission chair. The chair's term expires March 1, 2010.
- Jim Robison, Eagle River, is the former president of the Alaska AFL-CIO and the Alaska State District Council of Laborers; vice president of the Tri Trades Public Service Council and Operating Engineers; a former Commissioner of the Alaska Department of Labor for Governor William Sheffield. He served as a labor member of the workers' compensation board. He was reappointed to a five-year term March 1, 2006. His term expires on March 1, 2011. Employee representative.

- Stephen T. Hagedorn, Anchorage, has been employed by the Alaska Railroad Corporation for 22 years as the corporate Risk Manager. He has a bachelor's degree in history from the University of Northern Iowa. He served as a member for industry on the workers' compensation board for 15 years before he was appointed to a five-year term on March 1, 2007. His term expires on March 1, 2012. Employer representative.
- David W. Richards, Juneau and Eagle River, is a retired member of the Carpenters' Union Local 2247. He is seasonally employed by Miller Brothers Construction in Juneau as a superintendent, but resides in Eagle River the remainder of the year. He served as a member for labor on the workers' compensation board for three terms in Juneau, and, after starting his own contracting business, two terms as an industry representative. He was appointed to a five-year term on the commission in March 2008. His term expires on March 1, 2013. Employee representative.

The commission thanks Mr. John Giuchici, employee representative from Fairbanks, for his energetic service on the commission from appointment in November 2005 until the expiration of his term March 1, 2008. Mr. Giuchici's example of attention to factual detail left a profound mark on commission practice. During 2007, the term of Mr. Chris Johansen, an employer's representative from Fairbanks, who stepped in following the resignation of Mr. Marc Stemp, expired; his time on the commission was brief, but very productive, and the commission thanks him for his service.

• Appeals Filed in the Commission

The commission docketed 49 new cases in 2007, including 42 appeals and 7 motions for extraordinary review in 2007. In addition to the cases docketed in 2007, the commission began the year with 32 cases on the docket; two (2) of those 32 were filed in December 2005, and 30 were filed in 2006. A complete list of the commission's 2007 docket, with the results of dispositive decisions or orders and current status may be found at Appendix 1.

Table 1 shows the total number of active cases on the commission docket, the new cases filed and the production of work by the commission, from month to month in 2007. Of the 49 new cases filed in 2007, 34 were still open on January 2, 2008, but none

of these 2007 cases had been open more than 12 months at the date of this report. This closure rate represents a notable achievement in timely resolution of appeals. Of 42 cases filed in 2006,


only one, Appeal No. 06-036, originally filed as a motion for extraordinary review on

November 27, 2006, was still open on January 1, 2008. The commission issued the final decision in that case on February 7, 2008. The


increase in the commission's productivity is shown in Table 2 above.

The graph to the right compares the number and types of cases (Motions for Extraordinary Review and Appeals) filed in the commission




from 2005 through 2007.

The commission has noted considerable seasonal variation in filing new cases from year to year, as illustrated in the following chart.



Employees representing themselves filed 14 of the 49 appeals or motions for review in 2007. Nine (9) appeals or motions for review were filed by employees who were represented by counsel. Employers representing themselves filed three (3) appeals or motions for review. The remaining 23 appeals or motions for review were filed by employers or other parties who were represented. In all 17 self-represented appeals, the appellee was represented by legal counsel; in 32 appeals or motions filed by represented parties, only eight (8) appellees or respondents were self-represented. The chart below illustrates the participation of attorneys in appeals.



Motions to waive fees due to indigence have resulted in seven (7) appellants being found indigent and granted full or partial waiver of fees. The commission has ordered

seven (7) transcripts of board hearings prepared in indigents' appeals, plus one (1) transcript in a pro se appellant's case with a poor board recording, at a total cost to the commission of \$3,531.25. In addition, the commission prepared transcripts in four (4) cases for the Supreme Court, and in one case for the commission's use in a case filed by a self-represented appellant who had not requested indigent status. The total cost of transcripts in 2007 was \$5,095.75.

• Commission Decisions

In 2007, 42 published decisions were issued by the end of the reporting period. Appendix 2 lists the commission's 2007 published decisions, with days to decision and appeals to the Alaska Supreme Court noted. In addition, decisions issued in 2008 on cases heard in 2007 are listed.

Ninety days are allowed for commission decisions. The 2007 average time from oral argument (or close of briefing if no hearing was held) to decision distribution for decisions published in 2007 is 56 days. Including the seven (7) decisions published in 2008, but heard in 2007, the average is 60 days, well within the statutory allowance of 90 days. Of the 42 decisions published by the commission in 2007, one (1) decision was a week late owing to the absence of commissioners from the state. Notice was given to the parties of the anticipated delay.


Thirty (30) cases were closed following a decision on the merits in 2007. When the count includes cases heard in 2007 with decisions published in 2008, the total is 37 cases closed on the merits. In addition to cases closed by decisions on the merits, nine (9) cases were closed by order of dismissal due to settlement, two (2) cases were voluntarily dismissed by the appellant before briefing, five (5) cases were dismissed after notice of default due to failure to prosecute the appeal and two (2) cases were dismissed because the appeal was filed late. Six (6) cases are presently suspended for board action on a settlement agreement or awaiting stipulated dismissal.

The commission examined its action on the published decisions issued in 2007, and found that in 12 decisions the commission affirmed the board outright or on different

grounds, in seven (7) decisions it reversed the board or vacated a board decision and remanded, and in three (3) decisions, it reversed in part and affirmed in part. The numbers are small, of course, but the commission's reversal/vacation rate for 2007 was 32%; including partial reversals raises the rate of merit decisions finding error requiring remand to 45%.

The remaining published decisions include eight (8) decisions on motions for extraordinary review. The commission granted three (3) motions for extraordinary review and denied five (5) motions for review. One (1) motion for extraordinary review was found to be an appeal from a final board decision; the appeal has not been decided. The commission does not consider grant or denial of a motion for extraordinary review to be a decision on the merits of the challenged board order, although it is a decision on the merits of the request for extraordinary review. In two (2) decisions, the commission found there was no commission jurisdiction over the appeal owing to retained Superior Court jurisdiction. Nine (9) published decisions addressed such matters as late filed appeals, motions for stay, grants of indigent status, commission reconsideration,

representation by nonattorneys before the commission, dismissal for failure to prosecute the appeal following notice of default, recusal for cause, and finality of orders for penalty when



the board retains jurisdiction to adopt a calculation. The chart above illustrates the distribution of published decisions by type.

The commission adopted the example of the Alaska Labor Relations Agency of issuing bench orders, delivered verbally by the panel in a recorded hearing, when there are reasons (such as a pending board hearing) requiring notice of the commission's decision before the written decision is published. Bench orders are followed by a final written decision.

Nine appeals of commission decisions were filed in the Supreme Court in 2007, including one decision issued in 2006 that was appealed in 2007. Two of these appeals have settled. One petition for review was filed, which the Alaska Supreme Court accepted on March 5, 2008. A note indicating appealed decisions is contained in the list of commission decisions at appendix 2.

The commission held 45 hearings of oral argument that resulted in a decision or order. In addition, the commission held hearings on indigence motions, motions for stay pending appeal or similar motions without published decisions resulting. The commission issues orders on non-routine or contested motions, such as motions for stay pending appeal, motions for recusal or objection to the panel, motions to dismiss appeal for lack of jurisdiction, motions to waive fees for indigence, and motions for attorney fee awards. The commission chair may also issue orders on motions for extension of time, notices of default with orders to comply, and similar procedural matters. Unless the commission's decision and order on such motions provides guidance by illuminating a point of law, or is otherwise significant to the commission's jurisprudence, these orders are not published. The commission issued 117 unpublished orders of various types during 2007.

In addition to hearings, the commission chair conducted status hearings and conference calls for scheduling purposes. One case called for appointment of a chair *pro tem* due to the chair's conflict (former representation of the opposing party in the same matter). The chair *pro tem* was drawn from the Office of Administrative Hearings.

Commission Training

The commission has established a regular schedule of periodic training for the commissioners. The Alaska Labor Relations Agency and commission members attended joint training retired Superior Court Judge Elaine Andrews, Chief Administrative Law Judge Terry Thurbon, Ronald Ellis, former Chairman of the Ottawa Workers' Compensation Appeals Tribunal and recipient of the Canadian Council of Administrative Tribunals medal awarded at Vancouver, B.C. in 2007, and Assistant Attorney General Judy Bockmon.

The commission chair again approached the National Judicial College about providing training for commission members. Through the College, the commission chair secured the services of one of the College's instructors in judicial writing, retired Alaska Superior Court Judge Karen Hunt, who will direct training for the commission in 2008.

The commission and the Alaska Labor Relations Agency share a dedication to providing training to law students by providing summer clerkships. In 2007, the commission's volunteer summer intern was Karamvir S. Chadha, now a second year law student at the University of North Carolina, Chapel Hill. In 2008, the commission, with the Alaska Labor Relations Agency, has committed to taking two volunteer law student summer interns from the University of Seattle School of Law's "Summer in Alaska" program that houses its students at UAA. Summer in Alaska interns are enrolled in one class taught at UAA by a University of Seattle law professor, receive credit for their service at governmental or non-profit organizations, and pay their own housing costs.

The commission's interest in providing training and internship opportunities is spurred by the growing problem of injured workers being unable to obtain legal help and the increasing age of the claimant bar. Most claimant attorneys are sole practitioners who do not have the time or facilities to provide training to law students who probably will not return. The expectation is that one out of six student interns will return to practice in Alaska. The commission has undertaken, with the Alaska Labor Relations Agency, to expose a pool of students to the workers' compensation and labor relations field, train them in the Alaska adjudications process, and instruct them in good legal writing and analysis. To that end, and in order to overcome the barrier imposed by the lack of housing and pay, the commission requested legislative funding so that it may provide a housing allowance to rotating semester law student interns.

• Other Commission Activity

The process for transfer of records on appeal from the Alaska Workers' Compensation Board has been smooth, with few delays. Occasionally the commission still finds that documents are missing from the board record, requiring either a board search for the document, or a certification from the hearing chair that a copy supplied by a party is a copy of the record [referred to in the board decision] that was in the record at the time of hearing. The chair is thankful for the good will and valuable assistance of Marie Jankowski, the Workers' Compensation Division's Appeals Clerk, and the acting Chief of Adjudications, William Walters, in this effort.

In 2007, the chair established a regular publication schedule with Lexis-Nexis and Westlaw, the two largest commercial databases, the court system, and the Department of Labor and Workforce Development's website manager. Decisions from the previous week are posted on-line on Wednesdays. Standardization of publication format has resulted in uniform appearance and style.

The lack of a single unified-format website to post all administrative decisions in a free searchable index continues to be of concern. The Department of Labor and Workforce Development agencies do not share a single decision format or website; some decisions are not published online at all. The chair explored the possibility of obtaining federal grant funds for a unified, single format, searchable website for publication of all administrative decisions, to which the commission and other Department of Labor and Workforce Development agencies could post decisions. However, in discussion with the Office of Administrative Hearings the chair learned that the Office of Administrative Hearings plans to produce and manage a statewide website of administrative decisions using a simplified program and search function. The chair is working with the Chief Administrative Law Judge in this effort.

In another area of cooperation with the Office of Administrative Hearings, the chair is providing the Office of Administrative Hearings with data to allow the Office to send anonymous surveys to the participants in the commission process after final decisions are issued. This will provide the Office and commission information on "customer satisfaction" with the commission's hearings and decisions and identify areas that need improvement.

The chair is working with the Department's website manager to improve the website by posting online forms that may be completed online and printed by the user. This effort was stalled by the loss of the commission's first Clerk, Cathy Paramore, in May 2007. Although the position was promptly filled, it was vacated six months later, before the newly hired Clerk had acquired sufficient familiarity with the commission process to complete the project. Filling the position was delayed by reclassification of the position, but the commission chair hopes that this project can be restarted soon.

Together with the Alaska Labor Relations Agency staff, recording equipment upgrades were installed to coordinate with the VOIP phone system, which had resulted in loss of the analog speaker phone connection in 2006. The result has been a significant improvement in recording quality and no complaints about telephonic participants being unable to hear.

The Alaska Public Interest Research Group filed a lawsuit September 30, 2005, seeking a declaration that the commission was unconstitutional. The Supreme Court decided the suit in favor of the commission's constitutionality in *Alaska Public Interest Research Group v. State*, 167 P3d 27 (Alaska 2007), announced September 7, 2007. The commission was represented by Assistant Attorneys General Paul Lyle and Laura Bottger.

• Conclusion

In this second full year of the Commission's existence, the Commission's number of oral arguments and published decisions nearly doubled, and the number of orders increased as well. The Commission continued to provide training to its members, regularized publication of its decisions, and focused on establishing good practices in the production of decisions and orders. The commission chair also took steps to put in place the institutional mechanisms for performance-monitoring. Over the next year, the chair intends to complete public use forms, improve the public information forms and website, expand the training program, and prepare the commission staff for transition, so that the next chair will be able to join a smooth-running, fully-staffed and well-trained commission on March 1, 2010.
