## The Public is Watching

Whenever subcontractors, including sole proprietors, work on your project sites, you are the controlling employer. This means you are responsible for the unsafe acts of sole proprietors and other subcontractors on the worksite. OSHA Enforcement will not issue a citation to the sole proprietor. They can and will issue the citation to the controlling employer. Remind your employees and subcontractors that the PUBLIC IS WATCHING. Consultation has intervened numerous times when the public calls to report safety violations they witness. We try very hard to protect our CHASE participants from Enforcement. Even though the CHASE program offers some protections from

Enforcement, imminent danger, willful, and repeat violations are not protected under the CHASE program.
